FAMILY STATUS ACCOMMODATION POLICY: EVIDENCE IN ONTARIO UNIVERSITIES

Summary:

Out of 22 Ontario Universities:

- 6 (Carleton, Laurentian, McMaster, Queen's, Hearst, and York) have clearly developed Family Status Accommodation Policies in place
- 14 refer to family status accommodations in their policies compliant with the Ontario Human Rights Code. 2 (Western and Waterloo) have specific accommodations for breastfeeding
- 2 (Algoma and Royal Military) do not have any reference to family accommodation.
