Per Article 25.7 (a) the Employer and the Association will hold jointly an annual workshop for Members who are planning to apply for tenure and/or promotion.

Per Article 25.21 (b) and 25.22 (b) the Association and the University may agree to an extension of these deadlines, though such extensions should be minor in nature. The Chair of the committee(s) should communicate to candidates any delays or agreed to extensions in a timely manner.
